DESCRIPTIONS OF AUTHORIZED TRANSACTIONS:

Oil Deliveries: Any fuel delivered to your residence or place of business. A delivery slip will be left by the driver at the time of the delivery showing the amount of the transaction.

Service: Expenses incurred when a technician is dispatched to your residence or business. This includes but is not limited to diagnostic fees, annual tune-up and/or flat rate billing for repairs.

E-Z Service Plan/Service Plan Renewals: Current retail price for any new or renewing Service Plan. This includes but is not limited to full retail price, discounted retail price, BOGO offers, monthly and/or weekly recurring payments.

Monthly E-Z Pay Payment: 12 month recurring charge set up on your account. The designated amount may include costs for oil deliveries, E-Z Service Plan and/or annual Cap Fee. *This amount is subject to change during Budget reviews, Budget renewals and/or any unforeseen transactions rolled into the E-Z Pay Program. Written and/or verbal notice will be provided prior to adjusted amount being charged to your preferred payment method. For this reason, we recommend your preferred payment method be a credit card instead of a debit card.*

Expired E-Z Pay Balance: Any balance due on your account, that is part of the expired E-Z Pay Program, IS NOT rolled into the following E-Z Pay Program season. This amount could be, but is not limited to, fuel cost that exceed monthly payments, missed payments, increased fuel prices*, severe winter weather, reduced supplemental heat source and/or home additions. *Not applicable to customers on the Cap Program.

Cap Program Fee: Annual fee for enrollment into the Cap Program. Enrollment and fee are applied automatically each year in an effort to reduce postage and paper consumption, as well as making sure your comfort is made easy!

Finance Charges/Late Fees: Charges applied to your account if payment terms are not met. Please contact the office if you have any questions.

All Transactions: All transactions posted to your account. *We recommend your preferred payment method be a credit card instead of a checking account or debit card if you choose this option.*
